

KOMİSYON UYGULAMA YÖNETMELİĞİ (AB) 2021/2325**16 Aralık 2021**

Avrupa Parlamentosu ve Konseyinin 2018/848 sayılı Tüzüğü uyarınca, Birliğe organik ürünlerin ithalatı amacıyla 834/2007 sayılı Konsey Tüzüğü'nün 33(2) ve (3) maddeleri uyarınca tanınan üçüncü ülkelerin listesini ve kontrol otoriteleri ile kontrol organlarının listesinin oluşturulması

AVRUPA KOMİSYONU,

Avrupa Birliği'nin İşleyişine İlişkin Antlaşma'yı dikkate alarak,

Avrupa Parlamentosu ve Konseyinin 30 Mayıs 2018 tarihli, organik ürünlerin organik üretimi ve etiketlenmesine ilişkin ve 834/2007 sayılı Konsey Tüzüğünü (1) yürürlükten kaldırın 2018/848 sayılı Tüzüğü ve özellikle bu Tüzüğün 48(3) ve 57(2) Maddeleri dikkate alınarak,

Zira:

(1) (AB) 2018/848 sayılı Tüzüğün 45(1) maddesinin (b)(iii) bendi uyarınca, bir ürün, tanınmış bir üçüncü ülkenin eşdeğer üretim ve kontrol kurallarına uyması ve bu uyumu teyit eden ve söz konusu üçüncü ülkenin yetkili makamları, kontrol makamları veya kontrol kuruluşları tarafından verilmiş bir denetim sertifikasıyla ithal edilmesi koşuluyla, Birlik içinde organik ürün veya dönüşüm ürünü olarak piyasaya arz edilmek üzere ithal edilebilir. Söz konusu Tüzüğün 48(1) maddesi, bu bağlamda, tanınmış bir üçüncü ülkenin, (EC) 834/2007 sayılı Konsey Tüzüğü'nün (2) 33(2) maddesi uyarınca eşdeğerlik amacıyla tanınmış bir üçüncü ülke olduğunu açıklığa kavuşturmaktadır.

(2) Bu tanıma 31 Aralık 2026 tarihinde sona ermektedir. Bu üçüncü ülkeler, (AB) 2018/848 sayılı Tüzüğün 47. maddesi uyarınca bir ticaret anlaşması kapsamındaki tanıma sisteme sorunsuz bir geçiş sağlamak amacıyla, organik üretim ve kontrol kurallarının yürürlükteki ilgili Birlik kurallarına eşdeğer olmasını ve Komisyon tarafından tanımalarının denetlenmesine ilişkin tüm gerekliklere uymalarını sağlamaya devam etmeleri koşuluyla, bu tarihe kadar tanınmaya devam edecektir. Komisyon Delege Tüzüğü (AB) 2021/1342 (3) uyarınca.

(3) Bu Yönetmelik kapsamında belirlenen tanınmış üçüncü ülkelerin listesi, Şili, İsviçre ve Birleşik Krallık hariç olmak üzere, 1235/2008/EC sayılı Komisyon Yönetmeliği'nin (4) Ek III'ünde yayınlanan listeye dayanmaktadır; zira bu ülkelerde organik ürün ticareti belirli anlaşmalar kapsamındadır. Ancak, söz konusu listenin son değişikliğinden bu yana Komisyon tarafından bazı üçüncü ülkelerden alınan yeni bilgiler ışığında, bazı değişiklikler dikkate alınmalı ve liste buna göre uyarlanmalıdır.

(4) Arjantin tarafından sağlanan bilgilere göre, kontrol kurulu "Argencert" in adı "Ecocert Argentina SA" olarak değiştirilmiştir.

(6) Hindistan'a gelince, özellikle Hindistan tarafından denetlenen kontrol kuruluşları tarafından kontrol edilen işletmelerden, söz konusu üçüncü ülkeden, binlerce tonluk iddia edilen organik susam tohumu etilen oksit ('ETO') ile kirlenmiş ve çok sayıda sevkiyat ithal edilmiş ve bu durum Organik Tarım Bilgi Sistemi'nde (OFIS) yaklaşık 90 bildirime yol açmıştır. İnsanlar için kanserojen olan ETO'nun varlığının 2020'den önce organik ürünlerde tespit edildiği anlaşılmaktadır. Son otuz yılda ETO analizi için çeşitli güvenilir yöntemler geliştirilmiştir ve bu nedenle bu tür kirlenmeleri tespit etmek için kullanılabilir hale gelmiştir. Bu OFIS bildirimlerine gelince, sevkiyatlarda bulunan kirlenme seviyeleri genellikle ETO için belirlenen maksimum kalıntı seviyesini çok aşmış olup, kesin kirlenme seviyeleri sevkiyata bağlı olarak değişmiştir. Bu durum hem tüketicilerin yanlışmasına hem de önemli bir sağlık riskine yol açmıştır. ETO kontaminasyonunun meydana gelmesi ve tespit edilen yüksek konsantrasyonlar, ayrıca bu kontaminasyonlara karışan ve Hindistan yetkili makamının gözetimi altında bulunan kontrol kuruluşlarının kontrol sistemindeki arızanın temel nedenlerine ilişkin yanıt vermemesi ve bu kontrol kuruluşları ile yetkili makam tarafından alınan uygunsuz düzeltici önlemler, kontrollerin ve denetimin sağlamlığını tehlikeye atmaktadır. Ayrıca, Komisyon tarafından alınan bilgilere dayanarak, söz konusu OFIS bildirimlerinde yer alan bazı kontrol kuruluşlarının, Hindistan'ın Birliğe ithal edilebilecek ürünler açısından tanınma kapsamına saygı göstermediği anlaşılmaktadır. Tüm bu nedenlerden dolayı ve (EU) 2021/1342 sayılı Delege Yönetmeliği'nin 3. maddesinin (a) bendi uyarınca, aşağıdaki kontrol kuruluşları Hindistan yetkili makam tarafından tanınan kontrol kuruluşları listesinde yer almamalıdır: 'CU Inspections India Pvt Ltd', 'Ecocert India Pvt Ltd', 'Indian Organic Certification Agency (Indocert)', 'Lacon Quality Certifications Pvt Ltd' ve 'OneCert International Private Limited'.

(7) Komisyon Uygulama Tüzüğü (AB) 2020/2196 (5) ile değiştirilen 1235/2008 sayılı Tüzüğün (EC) III. Ek'i, JP-BIO-038 kod numarasını hatalı bir şekilde "Japon Tarım Standardı Sertifikasyon İttifakı" kontrol kuruluşuna atfettiştir; oysa bu kod numarası, Komisyon Uygulama Tüzüğü (AB) 2020/25 (6) ile "Akatonbo" kontrol kuruluşuna zaten atanmıştı. Bu nedenle "Japon Tarım Standardı Sertifikasyon İttifakı"na farklı bir kod atanmalıdır.

(8) Kore Cumhuriyeti, yetkili makamının "ORGANİK TANITIMI" kontrol kuruluşunu, yetkili makam tarafından tanınan kontrol kuruluşları listesine eklediğini Komisyona bildirmiştir.

(10) Komisyon tarafından, (EC) 834/2007 sayılı Tüzüğün 33(3) maddesi uyarınca, eşdeğer garantiler sağlayarak ürün ithalatı amacıyla üçüncü ülkelerde kontroller gerçekleştirmek ve sertifika düzenlemek üzere tanınan kontrol otoriteleri ve kontrol kuruluşlarının düzenlenmesi, (AB) 2018/848 sayılı Tüzük ile aşamalı olarak kaldırılmaktadır. Bu kontrol otoritelerine ve kontrol kuruluşlarına, Birlik kurallarına uygun ürünlerin ithalatı amacıyla tanınmaya hazırlanmaları için yeterli süre tanınması gerektiğinden, tanımları, (AB) 2021/1342 sayılı Tüzük uyarınca Komisyon tarafından tanımlarının denetlenmesine ilişkin tüm gereklilikleri yerine getirmeleri koşuluyla 31 Aralık 2024 tarihinde sona ermektedir.

(11) Bu Tüzük ile oluşturulan tanınmış kontrol otoriteleri ve kontrol kuruluşlarının listesi, (EC) 1235/2008 sayılı Tüzüğün Ek IV'ünde yayınlanan listeye dayanmaktadır. Ancak, söz konusu listenin son değişikliğinden bu yana Komisyon'a ulaşan yeni bilgiler ve yeni katılım taleplerilığında, listede bazı değişiklikler yapılması gerekmektedir. 1235/2008 sayılı Tüzüğün 11(1) maddesi uyarınca, yalnızca 834/2007 sayılı Tüzük kapsamında 30 Haziran 2021 tarihine kadar sunulan eksiksiz talepler dikkate alınmıştır.

Alınan bilgilere dayanarak, tanınma kapsamının A, B ve D ürün kategorileri için Fildişi Sahili, Mısır, Etiyopya ve Güney Afrika'yı ve Burundi, Kongo Demokratik Cumhuriyeti, Gana, Kenya, Ruanda, Tanzanya ve Uganda için tanınma kapsamının D ürün kategorisini kapsayacak şekilde genişletilmesi haklı görülmüştür.

Komisyon, alınan bilgilere dayanarak, söz konusu kontrol kuruluşunun adının "Albinspekt bio.inspecta" olarak değiştirilmesinin haklı olduğu sonucuna varmıştır. Ayrıca, Komisyon'a söz konusu kontrol kuruluşunun adresindeki bazı bilgilerin değiştiği bildirilmiştir.

Alınan bilgilere dayanarak, A ve D ürün kategorileri için tanınma kapsamının Birleşik Arap Emirlikleri'ni de kapsayacak şekilde genişletilmesi haklı görülmüştür.

(17) Bir tarafta Avrupa Birliği ve Avrupa Atom Enerjisi Topluluğu, diğer tarafta Büyük Britanya ve Kuzey İrlanda Birleşik Krallığı arasında, 2021/689 (7) sayılı Konsey Kararı ile imzalanan Ticaret ve İşbirliği Anlaşması, her iki tarafın mevcut organik mevzuatının ve kontrol sisteminin karşılıklı olarak eşdeğer kabul edilmesini öngörmektedir. Sonuç olarak, Birleşik Krallık'tan organik ürün ithalatı amacıyla 2020/2196 sayılı Uygulama Tüzüğü ile verilen 'Biyodinamik Derneği Sertifikasiyonu', 'Organik Çiftçiler ve Yetiştiriciler C. I. C', 'Organik Çiftçiler ve Yetiştiriciler (İskoçya) Ltd', 'Organik Gıda Federasyonu', 'Kaliteli Galce Gıda Sertifikasiyonu Ltd' ve 'Toprak Derneği Sertifikasiyonu Limited' kontrol kuruluşlarının tanınması geri çekilmelidir.

Alınan bilgilere dayanarak, A, B, D, E ve F ürün kategorileri için tanınma kapsamının Mısır'a, A, B, D ve E ürün kategorileri için Tayland'a ve Benin için tanınma kapsamının D ürün kategorisine ve Türkiye için B ürün kategorisine genişletilmesi haklı görülmüştür.
