FEES

This fee table applies to producers or producer group members with registered and/or certified production processes and administration sites located in any territory in the world, excluding the USA and Canada.

The system participation fee is calculated based on the total productive area for each product registered for GLOBALG.A.P. certification, including multiple growing cycles, i.e., the area that is registered for an annual certification cycle shall be tallied for each growing cycle and for each product. For Option 2 producer groups, the total productive area of the producer group members (including multiple growing cycles) is aggregated before applying the fee, rather than applying the fee to each individual producer group member's registered productive area. This is only applicable to area-based fees, i.e., it is not applicable to aquaculture, feed, GLOBALG.A.P. Chain of Custody, etc.
